## DECLARATION AND AGREEMENT

1. I understand that, subject to the discretion of Oversea-Chinese Banking Corporation Limited ("OCBC"), a Fund Transfer Facility may be made available to me.
2. I may apply for a transfer (the "Fund Transfer") in Singapore dollars (the "Applied Fund Transfer Amount"), subject to a minimum amount specified by OCBC, from my EasiCredit Account to any of my bank/credit card/credit line account(s) (the "Other Bank/Card/Credit Line Account(s)") held with any bank or financial institutions in Singapore, other than OCBC.
3. OCBC reserves the right to reject an application for a Fund Transfer in its entirety and/or approve only part of an Applied Fund Transfer Amount (such approved amount shall be referred to as the "Fund Transfer Amount") at its absolute discretion and without assigning any reason therefor.
4. OCBC may, on its approval of each Fund Transfer, debit the Fund Transfer Amount from my EasiCredit Account on the date of the approval letter issued by OCBC or such later date as determined by OCBC.
5. I shall be fully liable to OCBC for any and all amounts charged to and/or debited from my EasiCredit Account. Each Fund Transfer Amount charged to and debited from my EasiCredit Account will be treated in the same manner as my Instruction under the OCBC Terms and Conditions Governing Personal Line of Credit Accounts and will be reflected in the monthly Statement of Account issued by OCBC to me for my EasiCredit Account and payable by me in accordance with the OCBC Terms and Conditions Governing Personal Line of Credit Accounts.
6. OCBC may vary the interest rate chargeable, the basis of calculation of interest, fees and charges at any time in OCBC's sole discretion without any notice and without giving any reason therefor. The amount to be transferred cannot exceed the Approved Limit or (as the case may be) the available credit limit of my EasiCredit Account.
7. I will continue to make payment to my Other Card/Credit Line Account(s) until I have received confirmation that my EasiCredit Account has been debited in settlement of the Fund Transfer Amount. I further agree that OCBC shall not be liable for any overdue payment, charges, fees or interest, losses or damages that may be incurred thereby.
8. The OCBC Terms and Conditions Governing Personal Line of Credit Accounts shall apply. In the event of inconsistency between these terms stated herein and the OCBC Terms and Conditions Governing Personal Line of Credit Accounts, the OCBC Terms and Conditions Governing Personal Line of Credit Accounts shall prevail.
